Frederick was educated at West Banks School and Wick High School then went on to Edinburgh University where he graduated Master of Arts with first class honours. While studying in Edinburgh he was active in the Edinburgh Caithness Society. He followed his masters with a Ph.D. in Mediaeval History,

Dr Frederick Robertson was appointed County Librarian for Caithness and Sutherland in 1934 and continued in the role until his retirement on

which involved some studies in Paris, France.

In 1938 Fred married Margaret Bremner in Wick. They had two children, Margaret (Garry)

in 1942, and Duncan in 1949.

Fred was active in the Wick and Pulteneytown Mercantile Debating Society and a founder member of the Scottish National Party branch in Wick. He became an Honorary Sheriff Substitute for Caithness in the 1960s.

He died on the 1st of October 1993 in Wick aged 83.

The Sinclairs of Scotscalder

William Sinclair acquired the the lands of Ulgrimbeg and Ulgrimore in 1713, and the estate of Scotscalder in 1729. His son John was gifted these lands on his marriage in 1731.

John's second son, Captain Robert Sinclair, became third and last of Scotscalder. In addition to Scotscalder, he was Tacksman of Freswick and Dounreay. He had an only son, Lieutenant-Colonel James Sinclair of the Royal Artillery, and two daughters, one of whom married Mr Aitken, Factor for Captain Sinclair, and the other married Mr Steel, an excise officer (from Caithness Family History by John

Henderson, W.S., pp. 39-42).
