Administrative history: The Henderson Family

David Henderson was the heir of Alexander Henderson. He occupied the farm at Gerston and in 1750 purchased Stemster from Sir Benjamin Sinclair for 21,500 merks. He married Cecilia Honyman of Graemsay and had four sons and three daughters- William; Alexander, his successor; Patrick; John; Mary; Anne and Margaret.

Alexander Henderson of Stemster served in the Royal Navy before marrying Margaret Duthie of Arduthie. They had five sons and four daughters-David, his successor; Alexander; William; James, of Bilbster and Rosebank; Patrick; Margaret; Mary; Johanna; and Cecilia.

David Henderson Esquire of Stemster married Marjory Williamson, eldest daughter of Colonel Benjamin Henderson of Banniskirk on the 25th of May 1816. They had children Janet b.1817, Margaret b.1818, Alexander b.1820, Donaldina b.1822, Benjamin b.1823, Williamina b.1828, and David b.1833.

He died on the 31st of October 1859.

He was succeeded by his eldest son, Alexander, who married Susan;

daughter of Allan McFarlane and his wife Margaret, daughter of John Horne of Stirkoke in 1862. They had children Margaret b.1864, David Patrick b.1865, Jessie b.1866, Mary b.1868, Allan b.1869, Alexander b.1870, and Elizabeth b.1873.

David Patrick or D.P. Henderson succeeded his father as proprietor of the estates in 1895. He married Miss Annie Jeanette Sutherland of Wetherby Gardens, South Kensington in 1891. She was the daughter of H.H. Sutherland Esq., London.

He died on the 9th of March 1931. He was survived by a daughter, Susan Patricia, born 1892. In 1918 she married Lieutenant H.W. May. They had a daughter Jeanette (Jean) Henderson or May.

Jeanette Patricia Mary Henderson married Commander Victor C. Grenfell (d.1985) on the 4th of May 1962. She died on the 30th of October 1996.

Jeanette Patricia Mary Henderson or Grenfell transferred the titles of Stemster and Brabsterdorran Estates to Neil Patrick Dundas McCanlis in 1991.
