D123: Christie and Ferguson Solicitors' Records, 1835-1952

The firm Christie and Ferguson was the successor of the partnership Macdonald and Fraser (Ronald Macdonald and George Fraser), which in turn emerged from the practice of Alexander Macdonald, solicitor (1840 - 1899), who followed in the footsteps of his father, Harry Macdonald, writer.

The bulk of the records derive from Alexander Macdonald's practice from c.1873 to c.1900. Macdonald was factor to several estates during the 1880s, Skye's only lawyer for many years, a bank agent, the principal collector of rates and taxes, clerk to six school boards, member of seven parochial boards and Captain of the Portree Volunteers. In his later years he was joined in business by Ronald Macdonald (1866-1916), the son of a crofter from Glenhinisdale. Ronald studied law at Glasgow University and returned to Portree to work for Alexander Macdonald as a junior assistant, later rising to succeed the older Macdonald as solicitor and bank agent.
